## **Plans for Town Office**

Todd Bradt was present with plans from Palatine. He explained different parts of the plan and everyone viewed and discussed the plans. Mr. Bradt stated that he recommends the plans from Palatine instead of the ones from the Town of Manheim.

Supervisor Breh said that the town board members should visit both sites and it would be easier to decide which one that they like better

#### **Highway Report**

Scott DeNinno stated that the new truck has arrived.

Road sweeping is completed and cold patching has started.

The Youkers Bush Road bridge has been scheduled for diaphragm installation. This should allow for an increase to 15 ton weight limit.

The replacement culvert for Beldons Corner Road has been ordered.

Truck 2 (2004 International has been taken out of service due to frame and body rot. The chassis and body have reached the point where it is no longer cost effective to repair.

HL Gage has another CV dump truck similar to our new truck that they built as a demo and it is immediately available. The purchase price is \$168,450.80 with the same plow equipment as the new truck and a stainless combination dump body. Mr. DeNinno suggests purchasing this truck using CHIPS funds.

A highway agreement has been submitted for approval with the new truck purchase. Road Work to be completed in addition shall be: Replacement of Beldon Corners culvert, and widening completion for surfacing in 2023, elevation correction, grading and chip sealing of the remainder of Cline Road, re-grading and chip sealing of Krueger Road, Reprofiling and chip sealing of Montana Road.

A used 2009 Steering tandem plow has been located and can be purchased for \$28,000. Owner may be interested in partial trade of some of our used equipment. Mr. DeNiino will inquire and report next month.

Robert Pierce made a motion to accept the Highway Report and Nicholas Vasil seconded it and Kathleen Montana and Supervisor Breh were in favor.

## **Dog Control Officer**

Ty Stowell was absent but had a report for the board members.

Mr. Stowell received several calls about dogs at large on Route 29 by the school and they were reunited with their owner and reminded about the leash law.

He also had calls about dogs barking, and several missing animals.

#### **Codes Enforcement Officer**

Dave Rackmyre issued 4 new permits and the total permit fees year to date is \$932.20.

He stated that he is trying to find an address for someone who had a house fire and has all the junk on Route 29 so he can send her a violation notice,
