Supervisor Breh stated that there is an elected official who is receiving the health insurance. In 2015 the health insurance was taken away from the Superintendent of Highways. If it is given to one elected official, then it probably has to be available to all elected officials. If the elected officials do not want the insurance then they will be entitled to the buy-out. Robert Norris stated that the elected official with insurance is also an employee of the town. He does not think that the other elected officials should be offered the insurance.

Supervisor Breh said that if the town does not offer it then it could become a legal matter.

Robert Norris stated that he does not want to vote on it until he gets more information.

Bookkeeper Joanne Young said that we have to have the budget done tonight because it has to go to the County. She stated that we can put \$50,000 in A9060.8 for health insurance. This way it will be in the budget in case we have to offer it to all elected officials. If we have to offer it then there will be money in the budget for the buy-out.

It was decided to check with the Attorney to see if legally we have to offer it to the elected officials.

No residents were present to speak for or against the 2025 Budget.

Motion made by Robert Norris and seconded by Nicholas Vasil to close the public hearing at 7:05pm and Kathleen Montana and Supervisor Breh were in favor.
