Supervisor Cynthia Breh called the meeting to order at 6:30 pm with the Pledge to the Flag.

There were no public comments

Opening of bids

There was only 1 bid for millings and no bids for gasoline or diesel fuel.

Carver Sand & Gravel - \$19.25 per ton

Highway report

Countryman water conditioning has ordered the needed parts for the installation of the water treatment system. He will be calling to schedule once parts arrive.

Truck 4 (2008) Mack was towed to Utica Mack. It died while moving it around the yard here, and failed to re-start. It also had power steering leeks. The estimate of repairs is \$12,000. Mr. DeNinno recommended that we proceed with the repairs, as we cannot sell the truck in the state it currently is in.

Mr. DeNinno has been in contact with an engineer to evaluate the Lotville road bridge (culvert) for repairs. The steel I-beams of this bridge are in deteriorated condition and must be replaced, along with the wooden deck. Mr. DeNinno suggest that we post Lotville Road from Sweet Hill to King Road with a 4 ton weight limit.

Motion made by Robert Norris and seconded by Brian Miller to accept the Highway report and Kathleen Montana, Nicholas Vasil and Supervisor Breh were in favor.

Appointment of Deputy Superintendent

Superintendent of Highways Scott DeNinno appointed Brian Miller as Deputy Superintendent of Highways.

Dog Control Officer

The dog control officer had no report.

Codes Enforcement Officer

Dave Rackmyre submitted a report for the board members.

The total permit fees year to date is \$425.00.

He issued one certificate of compliance

Scott DeNinno stated that when he was Codes Enforcement officer he took in 5 times the amount of money that Dave Rackmyre has for building permits.

Robert Norris made a motion to accept the Code Enforcement Officers report and Nicholas Vasil seconded it and Kathleen Montana, Brian Miller and Supervisor Breh were in favor.

Bookkeepers Report

Joanne Capek-Young submitted a report for the board members.

Nicholas Vasil made a motion to accept the Bookkeepers report and Robert Norris seconded it and Kathleen Montana, Brian Miller and Supervisor Breh were in favor.

Town Clerks Report

Town Clerk Brys presented the report for February 2024.

Brian Miller made a motion to accept the town clerks report and Kathleen Montana seconded it and Nicholas Vasil, Robert Norris and Supervisor Breh were in favor.

Supervisor Report

Supervisor Breh said there was a resolution in 2015 to switch to M & T Bank. The board members were Stephanie Grey, Rodney Montana, Pat Haberek and Cheryl Lynch.

Supervisor Breh said that she had a count of the meetings that were missed for each board member,

Kathleen Montana only missed 1 meeting for 2021, 2022, and 2023

Nicholas Vasil has not missed any meetings

Supervisor Breh has only missed 1 meeting in 10 years

Robert Norris stated that he does not have to explain to the public why he misses meetings as he has a full time job.

Supervisor Breh said we need to do a Corrective Action Plan for the Capital Reserve Fund, Highway Debt Service Reserve Fund (DA) and a Highway Machinery & Equipment Fund (DA).

Brian Miller made a motion to accept Resolution #42 for the Capital Reserve Fund and Robert Norris seconded it, It is as follows:

ESTABLISHING A CAPITAL RESERVE FUND (A201.2)- RESOLUTION OF 08.21.2015
RESOLUTION #42

Resolved, that pursuant to Section 6-c of the General Municipal Law, as amended there is hereby established a capital reserve fund to be known as the "Capital Reserve Fund" The purpose of this reserve fund is to accumulate moneys to finance the cost of specific capital improvements. The specific items to be financed from the reserve fund are the construction/reconstruction of town buildings. The estimated maximum cost of such capital improvements is \$400,000.

The chief fiscal officer is hereby directed to deposit and secure the moneys of this Reserve Fund in the manner provided by section 10 of the General Municipal Law. The governing board/ the chief fiscal officer may invest the money in the Reserve Fund in the manner provided by Section 11 of the General Municipal Law and the investment policy of town of Oppenheim. Any interest earned or capital gains realized on the moneys so deposited or so invested shall accrue to and become part of the Reserve Fund. The chief fiscal officer shall account for the Reserve Fund in a manner which maintains the separate identity of the Reserve Fund and shows the date and amount of each sum paid into the fund, interest earned by the fund, capital gains or losses resulting from the sale of investments of the fund, the amount and date of each withdrawal from the fund and total assets of the fund, showing cash balance and a schedule of investments, and shall, at the end of each fiscal year, render to the Board a detailed report of the operation and condition of the reserve fund.

Except as otherwise provided by law, expenditures from the reserve fund shall be made only for the purpose for which the Reserve Fund was established. No expenditure shall be made from this Reserve Fund without the approval of the governing board and such additional actions proceedings as may be required by Section 6-c of the General Municipal Law and any other law.

Supervisor Breh stated that she can call the Attorney anytime she wants to because the resolution that was passed is illegal.

Robert Norris said that the Supervisor needs board approval. The Supervisor is part of the Town Board. He said the Supervisor has no more authority than the board members. He said that if the Supervisor calls the Attorney without approval, then she will be responsible for the call.

Supervisor Breh said she wants the Attorney come to our meeting every other month.

Robert Norris said that we don't need to pay the Attorney travel time plus to sit at the meeting. If we need him for something we will call him to come to the meeting.

Supervisor Breh made a motion to have the Attorney come to our meeting every other month and Nicholas Vasil seconded it.
